Jack went to school at Loddon Vale until he was 14 riding his horse there and back every day.

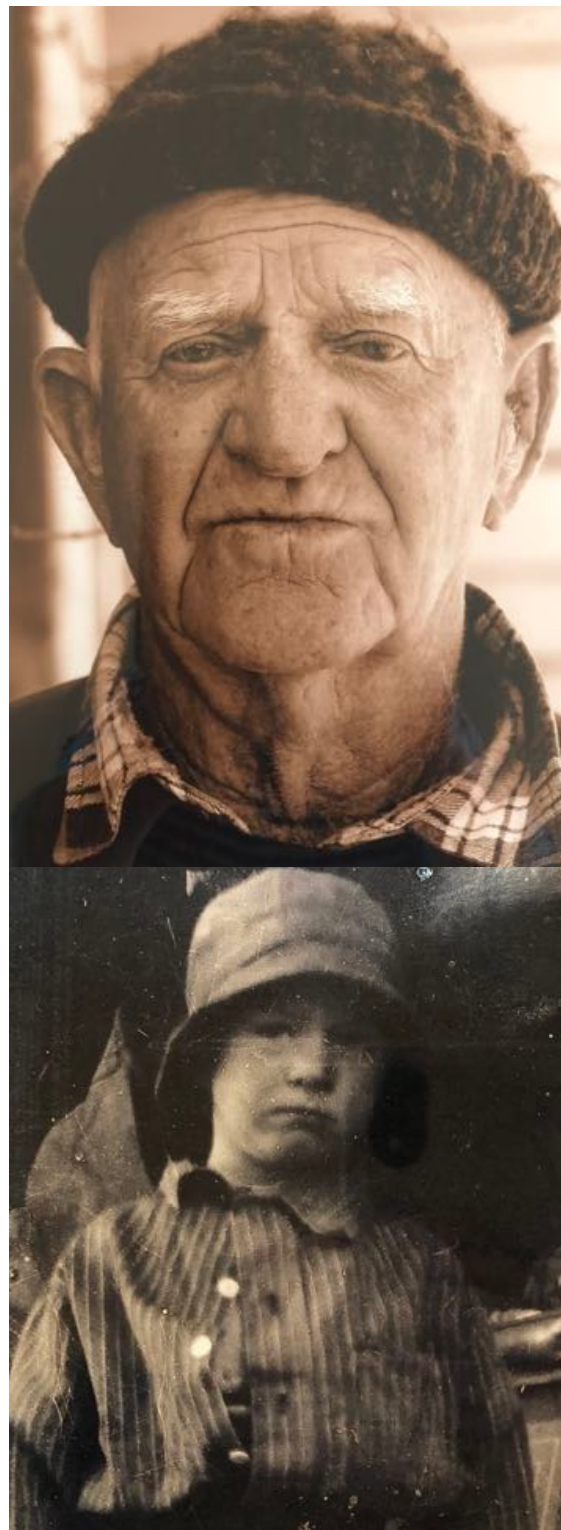

Early History of the Pyramid Hill Cooperative Store

October 5 1917

Co-Operative Society.

A Public Meeting of Farmers and Graziers will be held on Saturday, 13th inst, at 1.30 p.m. sharp, in the Victoria Hall, Pyramid, to consider the Establishment of a Co-operative Store

October 12 1917

The meeting in regard to a **Cooperative store**, to take place to-morrow, has been convened by Mr P. Spowart by request. Mr T A Burke, president of the Swan Hill Society, will attend

October 19 1917

A Co-Operative Store.

At the close of the meeting of the Agricultural Society last Saturday the president (Mr. P. Spowart) intimated that another meeting would follow, in connection with the proposal for a co-operative store at Pyramid. No doubt they would agree with him that it was about time that the farmers co operated to do their own business and get the profits therefrom. The meeting had that object in view He would have liked to see the hall full, in the interests of the producers. The farmers were too lax. The reinforcement having filed in the number present (was about 30 more or less.

Mr. Spowart was voted to the chair and introduced Mr. J A Burke, manager of the Swan Hill Co-operative Society and Mr. A. Hill Organiser.

Mr. Burke, who was well received, said he had had experience of small meetings. Sometimes they turned out very successful. In Gippsland there was one of the most progressive societies, yet at the initial meeting only four farmers turned up; and while he went to look for more two of them cleared out. (Laughter.) Yet that society was wonderfully progressive. They should not be disheartened because the meeting was not larger.

The Swan Hill Company was formed last year, and commenced on March 31st last. Their turnover was £52,000, representing sales of merchandise and the turnover in the agency and auctioneering branch was another £30,000. They held many important agencies, machinery, insurance, wheat-buying, etc., and the profits earned, which were very substantial, went directly to swell the profits earned by the Society for its own shareholders.

At a conference recently held in Melbourne, distributing co-operative concerns agreed to purchase jointly and the combined sales of the societies represented were over £300,000 per annum. The object of this was to effect further savings.

Mr. McKay had made a good offer. He had reached a time of life when rest was desirable. And his stock was available for purchase at cost price, nothing being asked for goodwill.

A letter from Mr. McKay was read in which he offered his store and butter factory at Mincha to facilitate the movement in the interests of the people.

On motion Mr. Marfleet and Mr. Moore it was agreed to form a provisional committee of 20.

The following were nominated— Messrs. Spowart, Marfleet, Dee, Moore, Mills, Hercus, McGillivray, Ottrey, MacRae, Norman, Jones, McKinnon, McIntyre, Miller Esler, Harrison, D. Townsend! Findlay and M. Smith.

The above were appointed a committee on motion of Messrs. Dripps and Plant. On motion of Messrs. Ottrey and Hercus, it was arranged that filling vacancies should devolve upon the Chairman and Organizer

Mr. Dee moved that Mr. A. Hill be appointed Organiser; seconded by Mr. Marfleet and carried.

Referring to the constitution of the committee, Mr. Ottrey said the area from which its members were selected should be of as wide a range as possible. It should reach the Loddon,

Replying to a question by Mr. Marfleet as to the qualification for a director, Mr. Hill said the movement being democratic there was no bar to a small shareholder becoming a director.

Replying to Mr. Dripps, Mr. Burke said the remuneration of the organiser was usually based on a percentage of the subscribed capital.

The committee decided what he was to be paid.

The next meeting will take place in three weeks or a month

April 19 1918

Some months ago the formation of a **Pyramid Co-operative Society Limited** was suggested, with the object of taking over the business of John McKay and Co. A large number of local residents intimated their desire to become shareholders in the concern, and during last month the matter was brought before the Treasurer of the Commonwealth for his approval and consent. The regulations of the War Precautions Act are very stringent, particularly with regard to the formation of new companies.

Any person who without the Treasurer's written consent, " takes any steps for the formation of any company or firm or any society, club or association having for its objects or one of its objects the pecuniary profit or gain of its members shall be guilty of an offence." The penalty for "an offence" against the Act is very severe. In this case the authorities were satisfied that everything was in order and the Treasurer's "written consent" was issued on the 21st March.

So the way is now clear and the necessary steps are being taken to form the society. The fact that the Treasurer of the Commonwealth has consented to the formation of the society is not to be taken in any way as a guarantee of the actual or probable financial stability or success of the society. It will be what the shareholders make it; the "consent" merely amounts to full permission to go ahead. A meeting of those interested will shortly be called and in all probability nominations for the directorate will be publicly invited at an early date. Until the Board of Directors is constituted nothing entailing financial responsibility can be undertaken.

May 3 1918

Pyramid Co-Operative Society Limited:

NOTICE TO SHAREHOLDERS. Nominations are hereby invited the seats on FIRST DIRECTORATE of the above named for Society. '

All shareholders are eligible to nominate or to be nominated. There are Seven (7) Seats to be filled.

Nominations will also be received for ONE AUDITOR to the Society.

Time fixed for closing nominations:— Friday, 17th May, 18, at 6 p.m.

May 10 1918

Writing in the early part of the week, Mr. J. H. Burke, manager of the **Swan Hill Co-operative Society Limited**, expressed deep regret at the absence of the directors and himself from the public meeting called for the 27th ult. The party had made all arrangements to visit Pyramid but were prevented by the state of the roads. The train service could not be availed of as they could not have returned to Swan Hill before the Monday night following.

Mr Burke writes :—"Had the party come, they would have placed before those present the desirableness "of entering into a strong local co-operation. We are anxious to see the Pyramid

Society successfully started, in order that it will be able to come in with us in our collective buying scheme, which enables big savings to be made. We now compete with Melbourne and Bendigo prices and our Society is in a highly prosperous condition. Our balance sheet, which will be sent to Pyramid in a few days, shows that not only the 10,000 shares originally authorised, but the additional 2000 shares which we obtained permission to sell, have all been taken up. For the first half-year (really five months) the net profit was £1416, and for the second half-year just closed the profit was £1793, clear of taxation.

The first year's trading will enable 7 1/2 per cent, interest to be paid on all the paid-up capital, a reserve fund starting with £700 has been created and £700 has been distributed in bonuses: The merchandise in the store amounts to £11,610, and the year's turnover is larger by £5000 than that of any country business in the state. We conduct a large pig market, clearing sales, horse sales and stock sales, and our machinery and insurance agencies are highly remunerative". The fact that this business was established in a town where strong competition in all branches of trade existed, and that it achieved the distinction of making more rapid progress in its first year than any other Victorian co-operative society had previously achieved is an encouragement to the Pyramid people to go and do likewise.

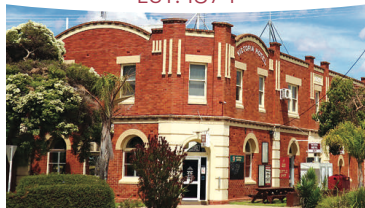
Shareholders in the Pyramid Co operative Society Ltd. are reminded that nominations for the seven seats on the first directorate will be received up till 6 p.m. on Friday next, 17th inst. A meeting of the Provisional Committee will then be held to fix the date for taking the ballot and to appoint scrutineers to conduct the election. The holder of ten shares is entitled to one ballot paper, twenty-five shares give the right to two ballot papers, and those who hold fifty shares or more are supplied with three papers.

It should be noted that no voting by proxy is permitted in the election of director or auditor.

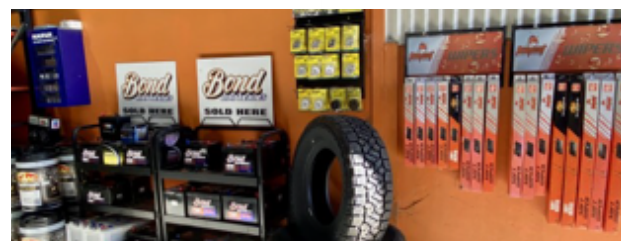

Community input key to Basin Plan's future

Goulburn-Murray Water is working with the Victorian Government and various other agencies to minimise the social-economic impacts of the recent changes to the Murray Darling Basin Plan.

In November 2023, changes were made to the Murray Darling Basin Plan that gave the Commonwealth Government greater scope to purchase water entitlements, removing water from irrigators' consumptive pool.

In response to these changes, the Victorian government recently published a prospectus titled *Planning our Basin Future Together*.

The prospectus reflects on previous instances where water entitlements have been purchased by the federal government and what could be done differently to create better outcomes.

GMW Managing Director Charmaine Quick said it was important there was a clear strategy in place for any buybacks.

"The changes to the Murray Darling Basin Plan have understandably caused concerns for many of the communities in our region," she said.

"In the past, buybacks programs have been conducted as open tenders for water purchases. This has meant they have been largely untargeted, creating a Swiss cheese effect, where the patchy nature of the buybacks means we are delivering less water but still have the same costs relating to infrastructure operation and maintenance.

"This makes water delivery less efficient and irrigation more costly."

Conversely, water delivery in northern Victoria has become more efficient in recent years, largely thanks to water recovery projects such as the Connections Project and the Water Efficiency Project that GMW delivered.

Together, these two projects have created more than 450GL of annual water savings. This has enabled GMW to provide additional water to the environment and for urban water security without affecting irrigators' consumptive pool, therefore benefitting the economy as well as the environment.

Community involvement was crucial to both projects, and Ms Quick said it was important for communities to be engaged with for future water recovery initiatives.

"It is important that we identify which areas water recovery will have the biggest benefits and least harm, and the best way to do this is by listening to our communities and understanding their needs," she said.

"It's by working together that we will arrive at the best outcome."
